## JUROR: Jordan Griska

Jordan Griska, a Brooklyn based sculptor, moved from Philadelphia in 2012. He received a BFA from the University of Pennsylvania and a Certificate from the Pennsylvania Academy of Fine Arts. Jordan received the Cresson Scholarship and Governor's Award while at PAFA.

Current public works installations include "Grumman Greenhouse" in Philadelphia and "Dolos" in Socrates Sculpture Park, Long Island City. Jordan was a 2011 West Prize finalist. Other selected exhibitions have been at Eastern State Penitentiary, Esther Klein Gallery, Fleishner Ollman Gallery, Scope Art Fair in Miami, and Philadelphia Contemporary.

He is currently working on a permanent installation at the Philadelphia Water Works Museum.

# Lancaster County Art Association National Juried Exhibition June 11-July 16, 2017

## Eligible Works

All original work in all media is eligible for entry. Work previously shown in the LCAA galleries will not be accepted. Artwork must have been completed in the past three years. The exhibit is open to all artists 18 years or older.

## Categories

1. Painting (oil or acrylic on canvas or panel),
2. Watermedia (watercolor, acrylic on paper, gouache, tempera),
3. Photography & Digital (film or digital photography, digital art),
4. 3-D (sculpture, ceramics, glass, fiber, jewelry),
5. Other Media (pastel, mixed media, drawing, hand-pulled prints, or encaustic).

*Note: mechanical reproductions are not acceptable, including reproductions that have been enhanced by the artist.*

## Awards

\$3,500 in cash prizes will be awarded by the juror.

- Best of Show - All Media - \$500
- First Place in each category - \$300
- Second Place in each category - \$200
- Third Place in each category - \$100

## Exhibition Dates

The exhibit will open with a reception on Sunday, June 11, 2017, from 1 - 4pm. Awards will be presented at that time. The exhibit will continue through July 16, 2017.

## Sales

All sales will be processed through the LCAA. The LCAA will retain a commission of 30%. Artwork not for sale should be marked "NFS". We will not accept work marked "Price on Request".

## Display of Work

All artwork must be framed and securely wired for hanging (saw tooth hangers are not acceptable). All 2-D work must be matted and framed under glass or plexiglass except oils and acrylics treated like oils. Work on canvas with finished edges is acceptable.

No frames that leave the edges of the glass exposed will be accepted. Entries should not exceed 45 inches in any direction (including the frame). Sculpture should be mounted on a suitable base. The LCAA reserves the right to reject any entry that is not suitable for display.

## Delivery and Return of Work

All accepted work must be hand-delivered to the LCAA at 149 Precision Ave., Strasburg, PA 17579 on June 2, 3 & 4. Artists who live more than 150 miles from the LCAA may ship their work which should arrive from May 24, 25 & 26. Pieces that weigh over 100 pounds must be hand-delivered on June 2, 3 & 4. All artwork must remain in the LCAA gallery until the close of the exhibit. Dates for pickup of artwork are July 20 - 23, 2017.

## Liability

The LCAA will insure artwork accepted into the exhibition for two thirds the listed sale price with a net maximum of \$1,000 per item. The LCAA will not be responsible for minor nicks to frames, breakage of glass or scratches to plexiglass.

## Rules for Entry

Artists must submit digital images (CD or by e-mail), a completed entry form and payment by April 1, 2017 to be eligible for jurying. 1 - 3 entries per artist.

## Digital Images:

- unenhanced, unmanipulated, oriented properly jpeg images saved at the highest quality standard setting for use on any computer including Apple computers.
- file size between 1 - 5 mbs and the longest dimension should be no longer than 1,600 pixels.
- file name using the artist's initials, image number from the entry form and one word from the title. (example: Jane Doe's image "Little Bear" #1 on her entry form would be jg1bear.jpeg).
- do not send files embedded in any application that must be run to view the .jpeg ending in .exe, or iPhoto Library folders.
- one image per piece for all categories except the 3-D category, which may submit 2 views per piece.

## Submitting by CD:

- follow rules for digital images above when saving files.
- write the following directly on CD with felt tipped pen (Sharpie, etc.), name of artist, titles of artwork, category entered. Do not send CD with a label attached to the CD.
- make sure the order and number of entries on CD correspond with the entry form.
- CD's will not be returned.

- package CD with adequate padding to avoid breakage.
- send with completed entry form, payment, & self-addressed stamped business size envelope to:

## Submitting by E-Mail:

- send 1-3 jpeg images following the rules under digital images above.
- send the jpeg images attached to an e-mail to lcaanews@yahoo.com.
- include your name, address, phone and category in your e-mail.
- download the pdf of the entry form from the website, fill out completely, and send attachment with your e-mail or print out and send by regular mail to the address below.
- remember to check the box on entry form for e-mail and mark the date the e-mail is sent.
- send your payment, include a copy of the entry form, and a self-addressed stamped business size envelope to:

- entry fees -  
\$10 per artwork by LCAA members  
\$15 per artwork by non-members
- checks should be made out to the Lancaster County Art Association
- to charge your entry fees (Visa, Mastercard, Discover), by calling the LCAA at 717-687-7061 during business hours Thursday - Saturday 11am - 4pm and Sunday 1 - 4pm.
- entry fees are non-refundable
- become a LCAA member and take advantage of the lower rate for entry fees. Include a separate check for membership - \$45 Adult, \$35 Senior (65+).
